Class A Share

May be sold to citizens of the Philippines or to partnership, corporations or associations of which 60% of the outstanding capital stock owned by Filipino Citizen.
Exclusive of government taxes

Class B Share

May be sold to any individual, corporation, partnership or associations, irrespective of nationality

Class C Share

Corporate Share – juridical entity with two (2) corporate nominee

Individual Share

Corporate Share

Same as above plus:

- Company profile
- Directors' Certificate / Secretary's Certificate indicating the nominee and his/her designation in the company. The nominee must be an officer or employee with executive status in the company. This must be expressly stated in the Directors' Certificate / Secretary's Certificate.
- A foreign applicant should present at the time of application, a valid visa or any document confirming valid entry to the Philippines (E.g. Alien Certificate of Registration (ACR), Philippine Retirement Authority (PRA), Alien Employment ID (AEP) or Diplomatic ID).
